**Eligibility :-**

- **Educational Qualification:** - Graduation in any branch with at least 'O' Level certificate in computer application from the Government Recognized Institutions.
- **Age:** - **Maximum** 40 years as on 01-01-2024.
- Applicant must be a resident of West Bengal.

**Selection Procedure:**

- (2) Examination will be held in three phases: (1) MCQ type written Test-70 marks (2) Computer Proficiency Test-20 marks (3) Interview cum personality test-10 marks.
- (3) Written test will be on following subjects: (i) General English-10 marks (ii) Numerical Ability-20 marks (iii) General Knowledge and Current Affairs-20 marks (iv) Computer Knowledge-20 marks

**Following self-attested photocopies of the documents are to be attached with the application: -**

- I. Admit Card of Madhyamik for age proof.
- II. EPIC for residential proof.
- III. Mark Sheets of all qualifications up to graduate level.
- IV. Certificate of Computer Application. (At least 'O' Level)
- V. Experience certificate in computer related work, if any.

- **Last date of Application: 31/03/2025**
- Twenty (20) candidates will be shortlisted based upon the marks of Written Test will be called for computer proficiency test & interview.
- Engagement shall be purely on contractual/ temporary basis for a period of (One) year. This can be renewed on satisfactory performance by the Finance Department on recommendation of the District Magistrate.
